	<p>Because the District has one new member, there are now eight members in the Clearfork Improvement and Service District. The Budget Hearing was delayed due to the illness of our Vice President and a lack of a President. In addition, the Secretary-Treasurer did not have an Internet connection for most of the month of June and could not download the budget form.</p> <p>At the Budget Hearing on August 7, 2016, a new President was elected and the Budget reviewed and approved by the majority of members.</p> <p>One former member owes the District several years' of payments. Because of this, the District will approach the County Commissioners about having the payments billed with the County Taxes.</p> <p>It is estimated that 6 of the 8 members will pay in full during the next year. Expenditures will be kept to the minimum for this next fiscal year.</p>
