

## BOARD OF COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS TUESDAY, DECEMBER 7, 2010

The regular meeting of the Board of County Commissioners was brought to order at 5:30 p.m. by Chairman Rob Hendry. Those in attendance were Chairman, Rob Hendry, Commissioners Ed Opella, Terry Wingerter, Matt Keating, Barb Peryam via phone, Deputy County Clerk Tracy Good, County Attorney Bill Knight, and Commissioners' Secretary Michelle Maines. County Clerk Renea Vitto was absent.

Commissioner Peryam moved to approve the Meeting Minutes of Proceedings for November 17, 2010. The motion was seconded and carried.

Commissioner Wingerter moved to approve the payment of bills in the amount of \$1,727,168.52. The motion was seconded and carried.

# A. Resolution 58-10 Transfer of Funds-Unanticipated Revenue

Deputy County Clerk Tracy Good reported the following transfer is in the amount of \$329,601.82 to be taken from unanticipated revenue and distributed to the following accounts: Commissioners/Projects, Grants Asset Forfeiture Expenditures-\$157,198.78; Commissioners/Projects, Grants ODP Region 2 Bomb Team-\$18,075.00; Commissioners/Projects, Grants Victim Emergency Service-\$3,279.00; Commissioners/Projects, Grants Victim Emergency Service-CPD-\$2,945.68; Commissioners/Projects, Grants Victim Services Salary Funds-\$2,354.00; Commissioners/Projects, Grants Victim Services Training & Equipment-\$17,213.80; Commissioners/Projects, Grants Victim Services Training & Equipment-CPD-\$14,679.20; Commissioners/Projects, Grants ODP Preparedness 2008-\$45,476.40; Commissioners/Projects, Grants Justice Assistance Grant-\$25,723.00; Commissioners/Projects, Grants Project Lifesaver-\$350.00; Sheriff/Administration Salaries-\$4,087.96; Sheriff/Administration Equipment-\$25,750.00; Sheriff/Detention Center Personnel Training-\$250.00; Commissioners/County Roads Morgan Street Road Improvements-\$12,219.00.

met all county standards; the district has utilized local funding sources; this letter completes the

Commissioner Keating reported the fire district ordered the new squad last week.
