



**BOARD OF COUNTY COMMISSIONERS  
MINUTES OF PROCEEDINGS  
October 2, 2012**

The regular meeting of the Board of County Commissioners was brought to order at 5:30 p.m. by Chairman Ed Opella. Those in attendance were Commissioners Bill McDowell, Rob Hendry, Terry Wingerter, County Attorney Bill Knight, Deputy County Attorney Heather Duncan-Malone, and County Clerk Renea Vitto.

Commissioner Hendry moved to approve the Minutes of Proceedings for September 25, 2012. The motion was seconded and carried.

Commissioner Wingerter moved to approve the payment of bills in the amount of \$1,021,311.86. The motion was seconded and carried.

**Public Hearings:**

**A. Non Motorized Pathway Easement**

Attorney Knight reported this is part of the Bridal Trail for property owned by Jack Dalton. Dalton property is a twenty acre parcel on the east side of the trail; perpetual easement is 10' x 20'. This is part of the process of solidifying the already public trail. This agreement has been prepared and approved as to form by the County Legal Department.

Attorney Malone reported that there are several more easements to follow. All these easements will be granted by the landowners voluntarily.

Chairman Opella opened the public hearing.

Hearing no comments in favor; one comment in opposition from Linda Bergeron, Casper, the floor was closed.

Commissioner McDowell moved for approval of the receipt of the Easement and suggested preparation of a resolution recognizing Jack Dalton and the history of land; it is wonderful that a citizen would grant an easement like this to the county and also recognition for what his grandparents did. The motion was seconded and carried.

**Commissioner Comments:**


